- 1) NCNDA, LOI
- 2) Seller issue FCO, Buyer sign & chop then revert with ICPO.
- 3) Seller issue SPA and to be signed by both parties.
- 4) Seller issue PI
- 5) Buyer issue IRLC with 1 month value of product
- 6) Seller open 2%PB
- 7) Seller shows linkage documents, eg. allocation letter & Lot/Batch number to buyer within 7 working days after confirmation of IRLC
- 8) start production
- 9) Buyer open DLC after receiving Lot/batch numbers & Allocation letter (transferred LC not accepted)
- 10) SGS inspection by buyer
- 11) release LC at sight

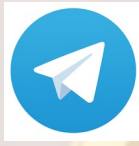
